Madge (Margaret Paterson) Hogarth (1892-1991)

Madge Hogarth was born in Portage La Prairie, Manitoba in 1892, and spent her early years in Winnipeg. During World War I she went overseas where she drove an ambulance. She there met and later married Lieutenant Colonel Donald MacDonald Hogarth (later Major General), a Canadian serving overseas with the Department of Supply and Transport.

On their return to Canada, a smoldering interest in the north was ignited when General Hogarth became deeply involved in sub arctic mining ventures. Although Madge never resided in a community north of Winnipeg, her interest in the north never waned.

Madge was deeply involved in churches in northern Canada, and in local and national charities. She supported and spent many hours working with the Grenville Mission, libraries and universities, as well as a number of recreational facilities and parks. Madge was the prime founder of the Vancouver Garden Club and was responsible for the installation of a fragrant garden for people with visual impairments and a garden for children with disabilities, both in Toronto.

General Hogarth died in 1950, and Madge moved from Toronto to Vancouver to be close to her brother, Dr. Donald Paterson and his wife, Dorothy. In 1967 Madge married Lyman Trumbull, a Vancouver businessman and philanthropist.

Madge was a practical, kind, caring and sharing person. She had a keen sense of humour and a joie de vivre. Her legacy for the north is The Madge Hogarth Foundation, and through it her faith and generosity live on. The Madge Hogarth Foundation, in existence since 1974, has assisted clergy and their small congregations to reach objectives they feel important in the practice of their religion and in the conduct of their lives within a Christian congregation.

Grant Range: \$1,000 - \$5,000

Eligibility

- Christian churches in isolated northern communities with populations of fewer than 5,000.
- Communities situated north of the 54th parallel and west of Hudson's Bay, including British Columbia, Alberta, Saskatchewan, Manitoba, the Yukon, the Northwest Territories and Nunavut. Please note that all of Nunavut is eligible for funding.
- Although not a high priority, flexibility in assessment will be exercised on compelling proposals from the capital cities of the Territories and from communities with populations of 5,000 or greater.
- Only one application per church is permitted per year, to a maximum of \$5,000.

Funding Priorities:

- Projects that serve and work with peoples of the North;
- Churches with a significant composition of First
 Nations people;
- Churches with ecumenical philosophies or projects with an ecumenical focus;
- Collaborative initiatives representing more than one Christian faith;
- Churches which make an effort to fund part of the project themselves;
- Projects that emphasize outreach to the community;
- Demonstrated need.

How to Apply

In a concise letter of not more than two pages, please answer the following questions:

- 1. What is the history of your organization?
- 2. How large is your congregation?
- 3. What are the history, size and nature of the community you serve?
- 4. What is the nearest significant town?
- 5. Which other Christian denominations serve in your community, and what is your relationship with those denominations?
- 6. Please provide a summary description of the project.
- 7. Which need(s) will your proposed project meet?
- 8. How will the project benefit the community as a whole?
- 9. What will the project cost, and how much are you requesting from The Madge Hogarth Foundation?
- 10. How do you plan to fund the project? Please identify any other funding sources.
- 11. Please ensure that the following information is also included: organization's name, address, phone number, e-mail, CRA Registration Number, and signature of the ordained minister responsible are included.

Please also attach the following documents to your application:

- A project budget (such as a quote, or summary of the costs for a project)
- A copy of your organization's most recent annual financial statement (operating statement and balance sheet)
